

**MADONNA PLACE**

*Waiver & Release from Liability*

1. I, \_\_\_\_\_, the undersigned, on behalf of myself, my heirs and next of kin, personal representative, agents, insurers, successors and assigns (all hereinafter "Releasors") hereby FOREVER RELEASE, DISCHARGE AND COVENANT NOT TO SUE MADONNA PLACE, INC., THE CITY OF NORWICH, NORWICH POLICE DEPARTMENT and the [SAMUEL HUNTINGTON SCHOOL], their insurers, affiliated administrators, agents, directors, officers, employees, members, committees, volunteers, ALL organizers of the Dodge Ball Tournament (as defined herein), and any and all participants, officials, referees, coaches, teams, sponsors, advertisers, owners, lessors and operators of premises used to conduct the Dodge Ball Tournament (all hereinafter "Releasees") from any and all liabilities, claims, demands, causes of action or losses of any kind or nature, past, present or future, direct or consequential that I may hereafter have for PERSONAL INJURY, PERMANENT, TEMPORARY, TOTAL OR PARTIAL DISABILITY, DISFIGUREMENT, PARALYSIS AND ANY OTHER LOSSES OR DAMAGES TO PERSON OR PROPERTY OR DEATH, arising out of my participation in, attendance at or traveling to and from the Dodge Ball Tournament, to be held on Saturday, March 24, 2012 at the Samuel Huntington School, 80 West Town Street, Norwich, CT.

2. Releasor understands and acknowledges that the Dodge Ball Tournament and the sport of Dodge Ball in general have inherent dangers that no amount of care, caution, training, instruction, supervision or expertise can eliminate, including the risk of serious injury, permanent, temporary, total or partial disability, disfigurement, paralysis and any other losses to person or property, including death, and that severe social and economic losses may result not only from Releasor's own action, inactions or negligence, but also from the actions, inactions or negligence of other notwithstanding the rules of play or the condition of the premises or of any equipment used. Releasor further acknowledges and fully understands that there may be other associated risks with such activities which are not known or not reasonably foreseeable at this time. RELEASOR EXPRESSLY AND VOLUNTARILY ASSUMES ALL RISK OF PERSONAL INJURY, PERMANENT, TEMPORARY, TOTAL OR PARTIAL DISABILITY, DISFIGUREMENT, PARALYSIS AND ANY OTHER LOSSES OR DAMAGES TO PERSON OR PROPERTY OR DEATH, sustained while participating in, attending, preparing for or traveling to and from the Dodge Ball Tournament, including the risk of PASSIVE OR ACTIVE NEGLIGENCE OF THE RELEASEES, or hidden, latent or obvious defects in the facilities or equipment used.

3. Releasor agrees that any and all disputes, actions and controversies between Releasor and the Releasees shall be subject to, should the Releasees so elect Connecticut law and the courts in Connecticut as the sole and exclusive venue for resolving any such disputes, actions and controversies.

I ACKNOWLEDGE THAT I HAVE HAD SUFFICIENT OPPORTUNITY TO REVIEW THE PROVISIONS OF THIS DOCUMENT AS WELL AS THE OFFICIAL TOURNAMENT RULES AND UNDERSTAND THEIR PURPOSE, MEANING AND INTENT.
